As a condition for Robin's Nest of Indy allowing me to adopt a cat, I am signing below to show that I agree to the following:

1. I will provide this cat with proper humane care, food, water, shelter, exercise and all other necessities.
2. I will keep this cat as a pet and companion.
3. I will provide this cat with veterinary treatment at my expense, including all necessary vaccinations. **Robin's Nest promotes regular check-ups and continued care and vaccinations with a veterinarian. Please be certain you are committed to this animal for its entire life before finalizing the adoption.**
4. I understand that once I have signed this agreement, any medical bills I incur for the care or treatment of my cat are solely my responsibility, and Robin's Nest will NOT reimburse me for them for any reason.
5. I will not declaw nor have a tendonectomy performed on this cat.
6. I will notify Robin's Nest immediately if I find, for any reason, that I am unable to keep this cat. I understand this does not guarantee that Robin's Nest will have the space or resources available to accept the cat back at that time.
7. I will never have the cat euthanized for any reason other than an end-stage injury or illness where the cat is suffering. Also, I will not surrender the cat to animal control or to any other organization without first notifying Robin's Nest.
8. I understand that this cat is an indoor only cat. I will never release the cat to the outdoors to fend for itself.
9. I understand that abuse, neglect or failure to comply with any of the provisions of this agreement could result in court proceedings to remove the cat from my custody.
10. I understand that the cat I am adopting is a "rescue animal," and that while Robin's Nest believes the cat has no serious medical or behavior problems, it is possible that a problem may exist and not be apparent, or that the stress of changing homes may cause a problem to develop that affects me, my family members or my other pets.
11. I understand that if I have followed this agreement, then for the first 14 days after adoption, I can return this cat to Robin's Nest for a full refund, and that for the first 30 days after adoption, I have a one-time right to exchange my adopted cat for another cat (subject to availability of other cats). Except for that refund or exchange right, I accept my new cat "as is" and, to the fullest extent permitted by law, WITHOUT OTHER GUARANTEES OR WARRANTIES OF ANY KIND, either express or implied, including warranties of merchantability or fitness for a particular purpose. I accept the risk of bringing such a "rescue animal" into my home and release and agree to hold Robin's Nest of Indy and any store in which I adopted the cat and their employees and volunteers harmless from any problem that may develop or claim that may be made. I agree this paragraph applies no matter what I may have been told.
12. I agree that by typing my name below I am "signing" this Agreement and it is a binding legal agreement.
